It is almost impossible these days to not see some sort of news, blog, tweet or post about the wave of workers joining Unions for a better life. Whether it's workers at 10 Starbucks locations winning their Union elections and 170 other locations petitioning for union elections or thousands of workers voting for Union representation at Amazon or even thousands of more workers in the cannabis industry joining the UFCW, one thing remains clear, that membership in Unions and collective bargaining creates a level playing field and gives workers a voice that is worth fighting for. Union members earn better wages and benefits than workers who aren't union members. On average, union workers' wages are 28 percent higher than their nonunion counterparts. Labor unions give workers the power to negotiate for more favorable working conditions and other benefits through collective bargaining. The National Labor Relations Board (NLRB) reports that from October 2021 through last month, 1,174 petitions were filed at the agency seeking union representation. That's up 57% from the same period a year earlier — and the highest level of union organizing in 10 years. This does not include the thousands of workers joining unions outside of the NLRB process through Card Check Neutrality Agreements like our newest members at Zara stores or the cannabis workers in Connecticut choosing representation through negotiated Labor Peace Agreements (LPA's).

These organizing efforts are true "David and Goliath" examples of collective strength, will and tenacity to achieve a win. Workers have leverage through collective action. These efforts and victories have been won despite vigorous and expensive anti-union campaigns led by management. Amazon for example, is reported to be spending millions of dollars on anti-union consultants, who are tasked with coming up with effective ways to keep workers from wanting to join a union. But workers to some degree, seem to be ignoring these tactics. The homegrown nature of these campaigns has employers employing decades-old cookie-cutter anti-union campaigns such as a "the Union is an outside third party" that doesn't understand or care about the concerns of employees and is more interested in collecting dues. But those arguments mostly ring hollow when the people doing the unionizing are workers they work alongside day in and day out.

Those of you reading this, are already protected by your own Union contract depending on which employer you work for. Your contract that has been negotiated and voted on, has so many of the protections, safeguards and benefits that so many of these workers are fighting and risking so much to achieve. These contracts do not come easy. Many current Local 919 members were personally instrumental in fighting off an anti-union campaign to win their voice on the job. If the latest wave of organizing efforts has taught me anything, it's that the benefits of Union Membership are so worth fighting for and protecting. President Espinosa and I, along with our dedicated staff remain so proud and honored to represent each of you while also remaining optimistic at the opportunity to help more workers in Connecticut join our Union. It is a thrilling time to be part of the labor movement!


